PLEASE READ THE FOLLOWING TERMS OF SERVICE AGREEMENT CAREFULLY. BY ACCESSING OR USING OUR WEBSITE (THE "SITE") OR OUR MOBILE APPPLICATION (THE "APP") OR OUR SERVICES, YOU HEREBY AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS AND ALL TERMS INCORPORATED HEREIN BY REFERENCE. IT IS THE RESPONSIBILITY OF YOU, THE USER, CUSTOMER, OR PROSPECTIVE CUSTOMER TO READ THE TERMS AND CONDITIONS BEFORE PROCEEDING TO USE THIS SITE OR APP OR SERVICES. IF YOU DO NOT EXPRESSLY AGREE TO ALL OF THE TERMS AND CONDITIONS, THEN PLEASE DO NOT ACCESS OR USE OUR SITE, OUR APP, OR OUR SERVICES.

The present terms and conditions (this "Agreement" or "Terms") is a legal agreement between you and Ocufii, Inc. (hereinafter "Ocufii"), a company duly organized and validly existing, located at 311 Buffalo Creek Road, Suite A, Lake Lure, North Carolina 28746. This Agreement annuls and voids all previous agreements.

## **OVERVIEW**

The Site (www.ocufii.com) and the Apps (Ocufii and NotifyMe) are operated by Ocufii, Inc. Throughout the Site and the Apps, the terms "we", "us" and "our" refer to Ocufii. Ocufii offers this Site and these Apps, including all information, tools and services available from this Site and these Apps to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our Site, and/or our Apps, and/or purchasing something from us, you engage in our "Service" and agree to be bound by the following terms and conditions, including those additional terms and conditions and policies referenced herein and/or available by hyperlink. These Terms apply to all users of the Site and the Apps, including without limitation users who are browsers, vendors, customers, merchants, and/or contributors of content. In the event of an inconsistency between this Agreement and any additional terms or policies referenced herein, the provisions of the additional terms or policies shall control.

Please read these Terms carefully before accessing or using our Site and/or our Apps. By accessing or using any part of the Site and/or the Apps, you agree to be bound by these Terms. If you do not agree to all the Terms of this Agreement, then you may not access the Site, or the Apps, or use any Service. If these Terms are considered an offer, acceptance is expressly limited to these Terms.

#### **SECTION 1 - GENERAL TERMS**

By agreeing to these Terms, you represent that you are at least the age of majority in your state or province of residence, or that you are the age of majority in your state or province of residence, and you have given us your consent to allow any of your minor dependents to use the Site and/or the Apps.

You may not use our products, and/or the Site, and/or the Apps, for any illegal or unauthorized purpose nor may you, in the use of our products, and/or the Site, and/or the Apps, violate any laws in your jurisdiction (including but not limited to motor vehicle laws).

You must not transmit any worms or viruses or any code of a destructive nature.
